## GENERAL

- The range hours are sunrise - sunset, 7 days / week
- Absolutely NO broadheads!
- Be safe - no horseplay, fighting, alcohol, etc.
- Respect the range - no littering, destruction of property or targets, etc.
- Always wear proper attire: no shirt, no shoes = no shooting!
- Always stay on designated path while others are shooting
- All minors are to be accompanied by an adult at all times
- Keep an eye out for critters in their natural habitat - snakes, armadillos, etc.
- Do not share your gate access - members have to accompany all guests
- Carry your membership card and ID whenever visiting the range

- It is the member's responsibility to ensure their guests are following all rules

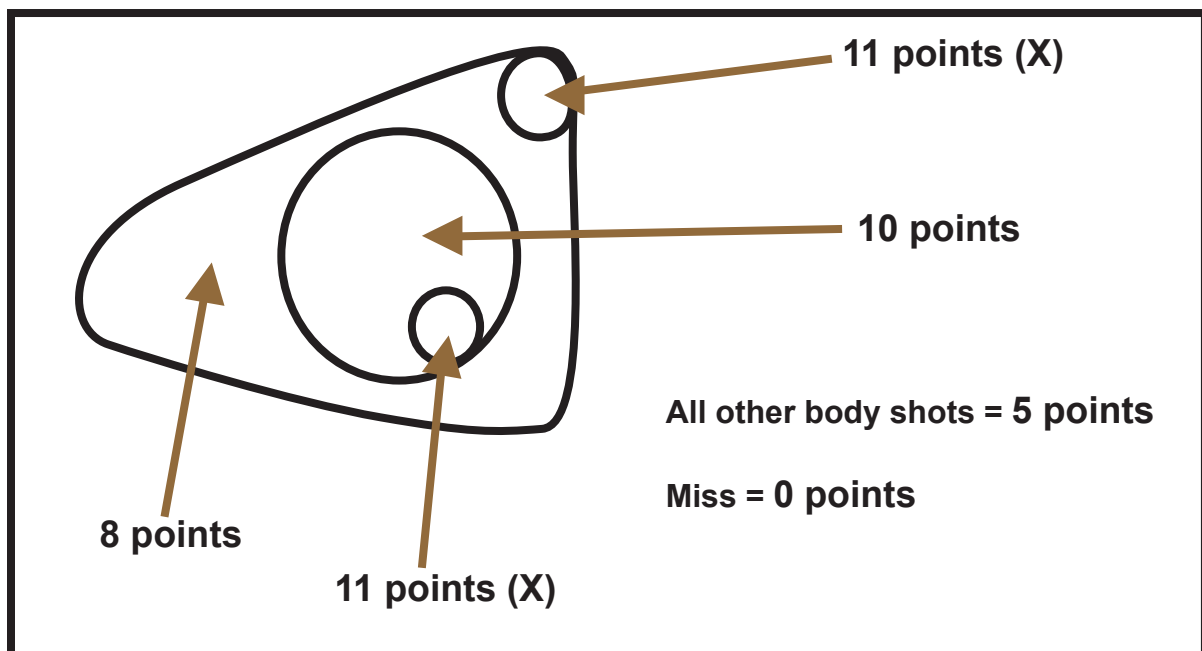

If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
